The portfolio manager takes speculative positions in Crypto Currencies based on the assessment of market conditions and other factors. Portfolios are managed on an aggressive basis following momentum strategies based on trending markets.

The portfolio manager seeks to benefit from growth opportunities as and when crypto currencies become tradeable, while also seeking to limit downside risk to general price declines and extreme volatility. Although the returns are dependent on general market movements, the technical analysis competence of the portfolio manager also attributes significantly to the overall portfolio performance.

INVESTMENT ASSETS

The portfolio manager can structure the cryptocurrency portfolio to include a range of cryptocurrencies, based on the sole discretion of the portfolio manager.

PORTFOLIO STRUCTURE

Each client's investment is valued on a daily basis and all transactions are verified by our Financial Director, Roeleen van den Heever CA(SA). The funds are invested on crypto exchanges which offer security and liquidity.

RISK MANAGEMENT

Volatility monitoring models reflect favourable trading conditions and liquidity risk is monitored on an ongoing basis.

WHO SHOULD INVEST?
